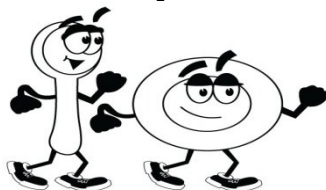

WAIVER AND RELEASE OF LIABILITY

2. I agree to indemnify and hold harmless the Hosts against any and all claims, suits or actions of any kind whatsoever for liability, damages, compensation or otherwise brought by me or anyone on my behalf, including attorneys' fees, if litigation arises on account of claims made by me or anyone on my behalf.

3. I agree to grant the Hosts full permission to use any photographs of the Event that contain my likeness for any purpose whatsoever.

4. I acknowledge that this Agreement is the entire agreement between the Hosts and me, and that this Agreement cannot be modified or changed in any way by representations or statements of the Host or by me.

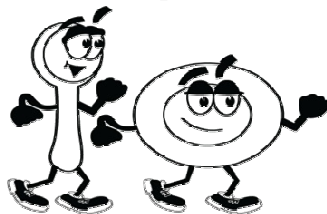
